I, EDMUND G. BROWN JR., Governor of the State of California, do hereby proclaim that a General Election will be held throughout this state on Tuesday, the seventh day of November, 1978, at which the following offices are to be filled:

ATTORNEY GENERAL;

MEMBER OF THE STATE BOARD OF EQUALIZATION from each of the four equalization districts of the state;

REPRESENTATIVES TO THE CONGRESS OF THE UNITED STATES from each of the forty-three congressional districts of the state;

STATE SENATORS from the even numbered districts of the forty senatorial districts of the state;

MEMBERS OF THE ASSEMBLY from each of the eighty assembly districts of the state;

ONE CHIEF JUSTICE OF THE SUPREME COURT;

THREE ASSOCIATE JUSTICES OF THE SUPREME COURT;

ONE PRESIDING JUSTICE, COURT OF APPEAL, FIRST APPELLATE DISTRICT, DIVISION ONE;

I further proclaim that at such election there will also be submitted to the vote of the electors such proposed constitutional amendments, questions, propositions and initiative measures as are required to be so submitted by the Constitution and laws of this state.

I further proclaim that there shall be held on the same day and consolidated with such General Election those Special Elections called by the Legislature and that there shall be submitted to the vote of the electors at such consolidated election those proposed constitutional amendments and other propositions which the Legislature has directed to be submitted at those Special Elections.
