PROCLAMATION

I, EDMUND G. BROWN, Governor of the State of California, do hereby proclaim that a General Election will be held throughout this State on Tuesday, the sixth day of November, 1962, at which the following offices are to be filled:

GOVERNOR;

LIEUTENANT GOVERNOR;

SECRETARY OF STATE;

CONTROLLER;

TREASURER;

ATTORNEY GENERAL;

SUPERINTENDENT OF PUBLIC INSTRUCTION;

MEMBER OF THE STATE BOARD OF EQUALIZATION from each of the four equalization districts of the State;

ONE UNITED STATES SENATOR;

REPRESENTATIVES TO THE CONGRESS OF THE UNITED STATES from each of the thirty-eight congressional districts of the State;

STATE SENATORS from each of the following twenty senatorial districts of the State: SECOND, FOURTH, SIXTH, EIGHTH, TENTH, TWELFTH, FOURTEENTH, SIXTEENTH, EIGHTEENTH, TWENTIETH, TWENTY-SECOND, TWENTY-FOURTH, TWENTY-SIXTH, TWENTY-EIGHTH, THIRTIETH, THIRTY-SECOND, THIRTY-FOURTH, THIRTY-SIXTH, THIRTY-EIGHTH, FORTIETH;

Also, such other state, county and judicial district, or other offices as are provided by law to be filled at such election.

I further proclaim that at such election there will also be submitted to the vote of the electors such proposed constitutional amendments, questions, propositions and initiative measure as are required to be so submitted by the Constitution and laws of this State.

I further proclaim that there shall be held on the same day and consolidated with such General Election those Special Elections called by the Legislature by Chapter 64 of the Statutes of 1962 (First Extraordinary Session) and Chapter 2 of the Statutes of 1962 (Third Extraordinary Session), and that there shall be submitted to the vote of the electors at such consolidated election those proposed constitutional amendments and other propositions which the Legislature has directed to be submitted at those Special Elections.

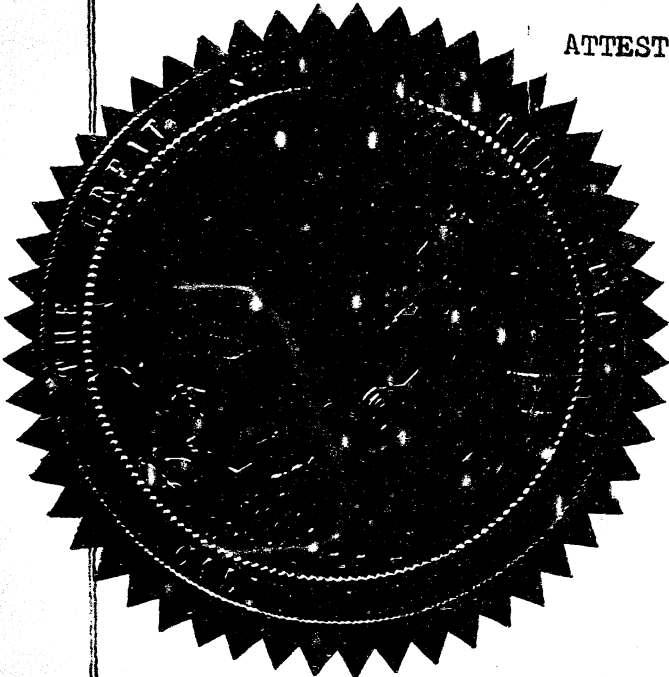
