PROCLAMATION

WHEREAS, during the 1963 regular session of the California Legislature S.B. 446 was enacted into law June 11, 1963, as Chapter 859, Statutes 1963, relating to the common boundary between the States of Arizona and California; and

WHEREAS, Section 1 of said Chapter 859 provides that the interstate compact, executed between the States of Arizona and California fixing the location of the boundary between the two states from the southern boundary of the State of Nevada to the point on the international boundary which is common to the boundaries of Arizona and California and the United Mexican States, is approved; and

WHEREAS, the provisions of the said interstate compact between the States of Arizona and California, referred to above, are set forth in section 1 of said Chapter 859; and

WHEREAS, section 2 of said Chapter 859 provides in part:

"The Governor of this state, whenever officially advised that the State of Arizona has ratified and approved the compact set forth in Section 1 and when the Congress of the United States has approved the compact, shall make proclamation of that fact.";

and

WHEREAS, I, EDMUND G. BROWN, as Governor of this state, have been officially advised and take notice that the State of Arizona did ratify and approve said compact upon the enactment April 2, 1963, of Chapter 77, S.B. 251, Twenty-Sixth Legislature, First Regular Session, State of Arizona; and


WHEREAS, I, EDMUND G. BROWN, as Governor of this state, have been officially advised and take notice that the 89th Congress of the United States did enact into law S.3249 on August 11, 1966, as Public Law 89-531 (80 Stat. 340) to consent to the interstate compact set forth in section 1 of said Chapter 859;

NOW, THEREFORE, I, EDMUND G. BROWN, Governor of the State of California, by virtue of the power vested in me by law, do hereby make Proclamation of the fact that the State of Arizona has ratified and approved the compact set forth in section 1 of Chapter 859, Statutes 1963, Regular Session; and


I do further Proclaim that the Congress of the United States has approved said compact; and

IT IS ORDERED AND DIRECTED that the Colorado River Boundary Commission of California cause a copy of this Proclamation to be published one time in one newspaper of general circulation in the county seat of Imperial, Riverside and San Bernardino Counties.

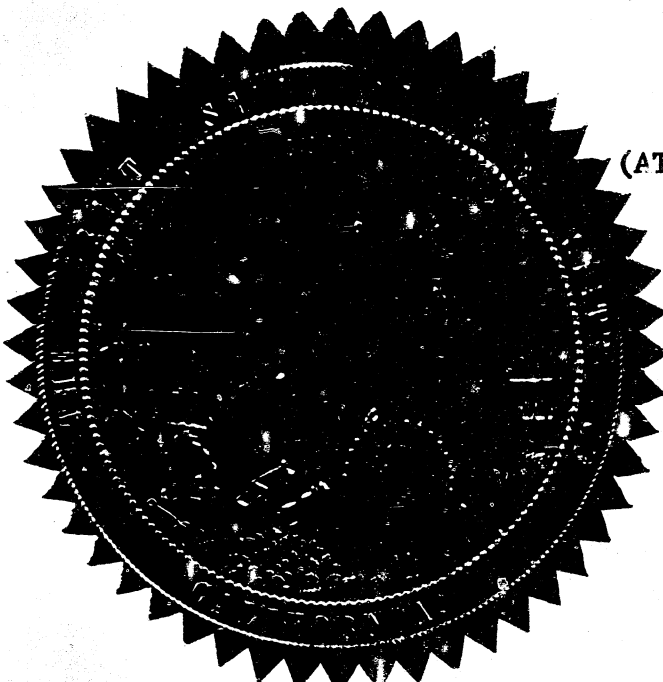
