I, EDMUND G. BROWN, Governor of the State of California, do hereby proclaim that a General Election will be held throughout this State on Tuesday, the eighth day of November, 1966, at which the following offices are to be filled:

I further proclaim that at such election there will also be submitted to the vote of the electors such proposed constitutional amendments, questions, propositions and initiative measures as are required to be so submitted by the Constitution and laws of this State.

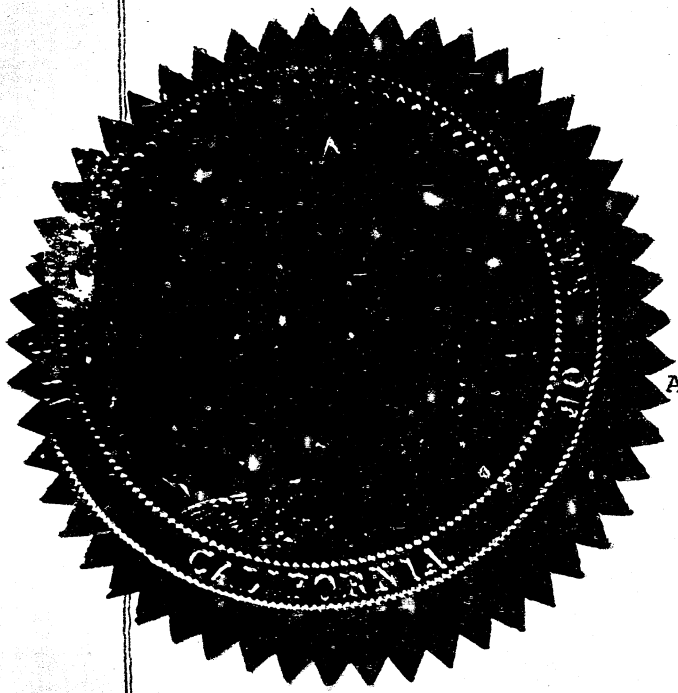
I further proclaim that there shall be held on the same day and consolidated with such General Election those Special Elections called by the Legislature by Chapters 29, 156, and 161 of the Statutes of 1966 (First Extraordinary Session),

and that there shall be submitted to the vote of the electors at such consolidated election those proposed constitutional amendments and other propositions which the Legislature has directed to be submitted at those Special Elections.

And I do hereby offer a reward of One Hundred Dollars (\$100) for the arrest and conviction of any person who violates any provisions of Division 15 of the Elections Code; the rewards to be paid until the total amount hereafter expended for the purpose reaches the sum of Ten Thousand Dollars (\$10,000.00).
