PROCLAMATION

WHEREAS, the Legislature of the State of California has been called in extraordinary session and has convened on February 10, 1966; and

WHEREAS, on account of extraordinary conditions which have arisen and now exist, it is deemed desirable and necessary to submit additional subjects to the Legislature for consideration; now, therefore,

I, **ROBERT G. McNAMARA**, Governor of the State of California, by virtue of the power vested in me by law, hereby amend and supplement my Proclamation dated February 9, 1966, by adding the following additional purposes thereto, and thereby permitting the Legislature to legislate upon the following subjects, in addition to the subjects specified in the original Proclamation, to wit:

Item No. 54. To consider and act upon a revision of Article III of the California Constitution.

Item No. 55. To consider and act upon a revision of Article IV of the California Constitution.

Item No. 56. To consider and act upon a revision of Article VI of the California Constitution.

Item No. 57. To consider and act upon legislation relative to legislators' compensation, expenses, and conflicts of interest.

Item No. 58. To consider and act upon legislation relative to regulation and control of DDT (Dichlorodiphenyltrichloroethane).

Item No. 59. To consider and act upon legislation relative to making the California Marketing Act of 1947 applicable to seafood.

Item No. 60. To consider and act upon legislation relative to health and welfare benefit plan coverage for school district employees.

Item No. 61. To consider and act upon legislation relative to regulation and control of LDD (Lysergic acid diethylamide).

Item No. 62. To consider and act upon legislation relative to the conversion of overhead electrical and communication facilities to underground locations.

Item No. 63. To consider and act upon legislation relative to fees charged by counties for county services.

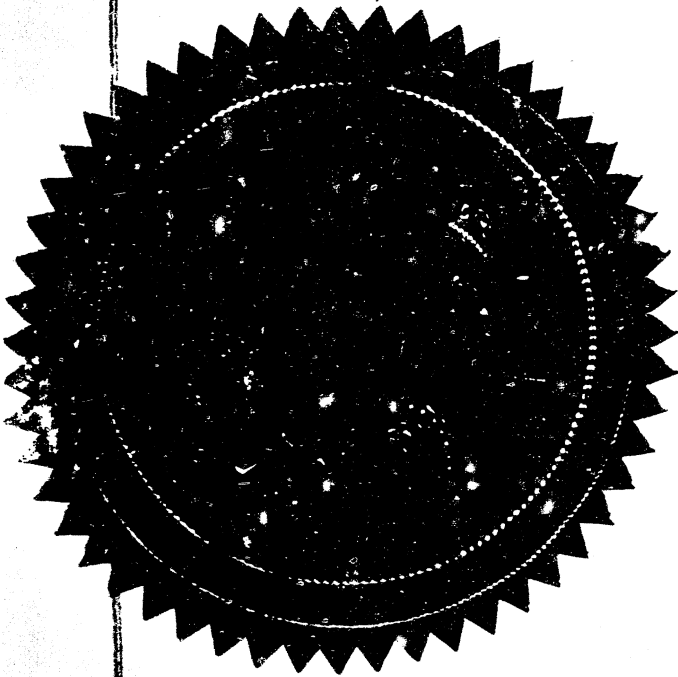
Item No. 64. To consider and act upon legislation relative to savings and loan association dividends.

Item No. 65. To consider and act upon legislation relative to workmen's compensation benefits.

Item No. 66. To consider and act upon legislation relative to retirement of local police officers under the State Employees' Retirement System.

Item No. 67. To consider and act upon legislation relative to state cooperation and participation with federal government with respect to recreation and fish and wildlife enhancement facilities at federal water projects.
