PROCLAMATION

I, EDMUND G. BROWN, Governor of the State of California, do hereby proclaim that a General Election will be held throughout this State on Tuesday, the eighth day of November, 1960, at which the following offices are to be filled:

THIRTY-TWO ELECTORS OF PRESIDENT and VICE PRESIDENT OF THE United States;

REPRESENTATIVES TO THE CONGRESS OF THE UNITED STATES from each of the thirty congressional districts of the State;

STATE SENATORS from each of the following twenty senatorial districts of the State: FIRST, THIRD, FIFTH, SEVENTH, NINTH, ELEVENTH, THIRTEENTH, FIFTEENTH, SEVENTEENTH, NINETEENTH, TWENTY-FIRST, TWENTY-THIRD, TWENTY-FIFTH, TWENTY-SEVENTH, TWENTY-NINTH, THIRTY-FIRST, THIRTY-THIRD, THIRTY-FIFTH, THIRTY-SEVENTH, THIRTY-NINTH;

MEMBERS OF THE ASSEMBLY from each of the eighty assembly districts of the State;

THREE ASSOCIATE JUSTICES OF THE SUPREME COURT for the terms prescribed by law;

ONE PRESIDING JUSTICE, DISTRICT COURT OF APPEAL, FIRST APPELLATE DISTRICT, DIVISION ONE, for the term prescribed by law;

TWO ASSOCIATE JUSTICES, DISTRICT COURT OF APPEAL, FIRST APPELLATE DISTRICT, DIVISION ONE, for the terms prescribed by law;

ONE ASSOCIATE JUSTICE, DISTRICT COURT OF APPEAL, FIRST APPELLATE DISTRICT, DIVISION TWO, for the term prescribed by law;

ONE PRESIDING JUSTICE, DISTRICT COURT OF APPEAL, SECOND APPELLATE DISTRICT, DIVISION ONE, for the term prescribed by law;

ONE ASSOCIATE JUSTICE, DISTRICT COURT OF APPEAL, SECOND APPELLATE DISTRICT, DIVISION TWO, for the term prescribed by law;

ONE ASSOCIATE JUSTICE, DISTRICT COURT OF APPEAL, SECOND APPELLATE DISTRICT, DIVISION THREE, for the term prescribed by law;

TWO ASSOCIATE JUSTICES, DISTRICT COURT OF APPEAL, FOURTH APPELLATE DISTRICT, for the terms prescribed by law;

ONE JUDGE OF THE SUPERIOR COURT - LAKE COUNTY;

ONE JUDGE OF THE SUPERIOR COURT - OFFICE NO. 9 - CITY AND COUNTY OF SAN FRANCISCO.

Also, such other county and judicial district, or other offices as are provided by law to be filled at such election.


I further proclaim that at such election there will also be submitted to the vote of the electors such proposed constitutional amendments, questions, propositions and initiative measures as are required to be so submitted by the Constitution and laws of this State.

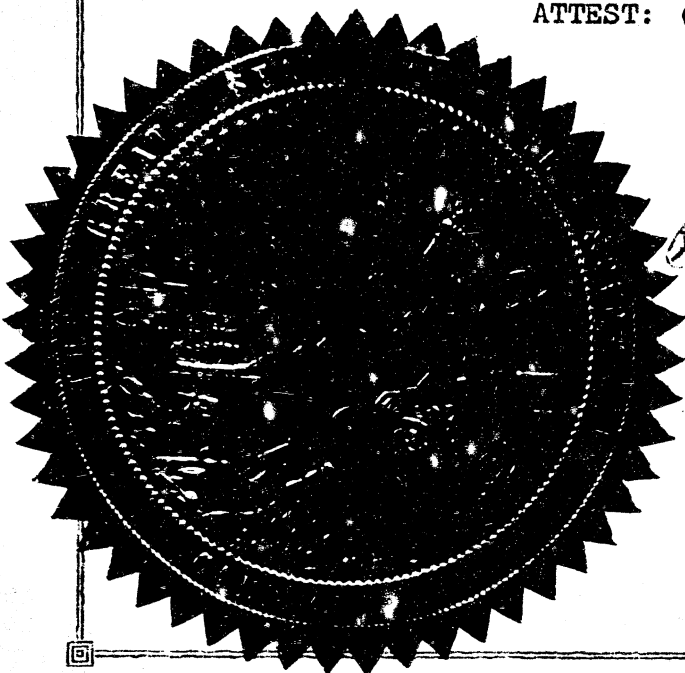
And I do hereby offer a reward of One Hundred Dollars (\$100) for the arrest and conviction of any person who violates any of the provisions of Division XIV of the Elections Code; the rewards to be paid until the total amount hereafter expended for the purpose reaches the sum of Ten Thousand Dollars (\$10,000.00).
