I further proclaim that at such election there will also be submitted to the vote of the electors such proposed constitutional amendments, questions, propositions and initiative measures as are required to be so submitted by the Constitution and laws of this state.

I further proclaim that there shall be held on the same day and consolidated with such General Election those special elections called by the Legislature and that there shall be submitted to the vote of the electors as such consolidated election those proposed constitutional amendments and other propositions which the Legislature has directed to be submitted at those special elections.


