*An act granting consent of the Legislature to the  
division of California into two new states.*

LEGISLATIVE COUNSEL'S DIGEST

SB 1092, as introduced, Collier (G.O.). Division of state.  
New act.

Expresses consent of Legislature to division of state and describes boundaries of two new states.

To become operative upon adoption of constitutional amendment authorizing Legislature to consent to division of state.

Vote—Majority; Appropriation—No; Fiscal Committee—No.

*The people of the State of California do enact as follows:*

1 SECTION 1. In compliance with Section 3 of Article IV of  
2 the United States Constitution, the Legislature hereby grants  
3 its consent to the formation within the existing boundaries of  
4 the State of California of two new states, the first to consist  
5 of all that territory in the State of California north of the  
6 line described in Section 2 and the second to consist of all that  
7 territory in the State of California south of the line described  
8 in Section 2.

9 SEC. 2. The dividing line between the two new states re-  
10ferred to in Section 1 is particularly described as follows:

11 Beginning at the intersection of the westerly boundary of  
12 the County of Ventura with the Pacific Ocean; thence north-  
13erly along said last mentioned boundary to the point at which  
14 it intersects with the boundary of the County of Kern; thence  
15 easterly along the southern boundary of the County of Kern  
16 to the point at which such boundary intersects with the bound-  
17ary of the County of San Bernardino; thence northerly along  
18 the eastern boundary of the County of Kern to the point at  
19 which it intersects with the County of Inyo; and thence east-

1 erly along the common boundary of the County of Inyo and  
2 County of San Bernardino to the point at which it intersects  
3 with the eastern boundary of the State of California.  
4 Sec. 3. This act shall become operative upon adoption by  
5 the people of a constitutional amendment authorizing the  
6 Legislature to consent to the division of the state.

3 *SEC. 2. Beginning at the intersection of the northern*  
4 *boundary of the County of Marin with the Pacific Ocean;*  
5 *thence southeasterly along the boundary to the point at which*  
6 *it intersects with the boundaries of the Counties of Sonoma,*  
7 *Solano, and Contra Costa; thence southerly along the eastern*  
8 *boundary of the County of Marin to the point at which it*  
9 *intersects with the boundary of the City and County of San*  
10 *Francisco; thence along the eastern boundary of the City and*  
11 *County of San Francisco to the point at which it intersects*  
12 *with the boundaries of the Counties of Contra Costa and Ala-*  
13 *ameda; thence easterly along the northern boundary of the*  
14 *County of Alameda to the point at which it intersects with*  
15 *the boundary of the County of San Joaquin; thence southerly*  
16 *along the eastern boundary of the County of Alameda to the*  
17 *point at which it intersects with the boundaries of the Coun-*  
18 *ties of Santa Clara and Stanislaus; thence southerly along*  
19 *the eastern boundary of the County of Santa Clara to the*  
20 *point at which it intersects with the boundary of the County*  
21 *of San Benito; thence westerly along the northern boundary*  
22 *of the County of San Benito to the point at which it intersects*  
23 *with the boundary of the County of Monterey; thence south-*  
24 *easterly along the eastern boundary of the County of Monterey*  
25 *to the point at which it intersects with the boundary of the*  
26 *County of San Luis Obispo; thence easterly along the north-*  
27 *ern boundary of the County of San Luis Obispo to the point*  
28 *at which it intersects with the boundary of the County of*  
29 *Kern; thence southeasterly along the eastern boundary of the*  
30 *County of San Luis Obispo to the point at which it intersects*  
31 *the northern boundary of the County of Santa Barbara; thence*  
32 *easterly along the southern boundary of the County of Kern*  
33 *to the point at which it intersects with the boundary of the*  
34 *County of San Bernardino; thence southerly along the east-*  
35 *ern boundary of the County of Los Angeles to the point at*  
36 *which it intersects with the boundary of the County of Orange;*  
37 *thence southeasterly along the eastern boundary of the County*  
38 *of Orange to the point at which it intersects with the bound-*  
39 *aries of the Counties of San Diego and Riverside; thence east-*  
40 *erly along the northern boundary of the County of San Diego*  
41 *to the point at which it intersects with the boundary of the*  
42 *County of Imperial; and thence southerly along the eastern*  
43 *boundary of the County of San Diego to the point at which*  
44 *it intersects the border of Mexico.*

45 *Sec. 3. This act shall become operative upon adoption by*  
46 *the people of a constitutional amendment authorizing the*  
47 *Legislature to consent to the division of the state.*
