

 - Research Trainings





Other State Law—Effective dates

Common Question:

How did a specific (out of state) law read during a specific period?

- Generally, you need to use the databases
- Multi-step process

STEPS

LOOK UP CURRENT LAW

ANNOTATED CODE FOR CODE SECTION HISTORY

LAW GOVERNING EFFECTIVE DATES

LOOK UP HISTORIC LAW

AMENDMENT OR CODE JUST PRIOR TO DATE

FOR THOROUGHNESS: AMENDMENT JUST AFTER DATE

HISTORIC VERSION OF EFFECTIVE DATE LAW







Check the Catalog and Databases First


- If we don't have it

Check the Catalog and Databases First


- Go to your Local Library
 - Ask about their resource sharing program
 - Follow their request procedures
- Be Aware



- Pre-1995 laws:
 - 1911-1987 Laws
 - Look up Chaptered Laws (Assembly site)
 - Convert Statutes to Bills (Our tool)-AB 3539
 - Look up Bill Versions (Hathitrust)
 - 1974-1995 Laws
 - Look up Assembly File Analysis (Onsite)


Database Checks--HeinOnline

- HeinOnline
 - Keyword search
 - Library Distribution Act
 - Contextual Articles
 - SCCLL News 34 (2008)
 - Documents to the People (March, 1992)
 - AG Opinions
 - Didn't see anything directly but there were several opinions that mentioned the State Library



Related Regulations

- Search via Office of Administrative Law
 - 14901
 - Government publication
 - State Library
- Not much—Contextual Library Use Policies—5
 CCR § 20004
 - History is short:
 - Register 82, No. 19
 - Register Supplements (Onsite)
 - Notice Registers (Onsite)

Started with Google Scholar


Usual keywords—but the library isn't particularly litigious
